**For the purpose of these minimum qualifications, experience in risk management is defined as responsibility for analyzing possible losses (financial, legal, credit risks or accidents, etc.) for an organization by determining, minimizing and preventing accidental loss.

***For the purpose of these minimum qualifications, experience in quality control is defined as responsibility for implementing a procedure or set of procedures to ensure that a product or performed service adheres to a defined set of standards.

****For the purpose of these minimum qualifications, experience in health and safety management is defined as responsibility for implementing procedures and/or practices that identify workplace hazards and reduce accidents.
