TITLE: PEDIATRIC NURSE SPECIALIST - (*Provisional Appointment)

SALARY: \$35,452 - \$47,387 annually

LOCATION: Monroe County Department of Public Health - **2 Part Time Positions**

JOB SUMMARY:

This is a professional public health nursing position responsible for the provision of primary health care to children in foster care. The incumbent is also responsible for periodic re-evaluation of the nursing needs of children in foster care. This employee works under general supervision from, and reports directly to, a Nurse Manager, Nurse Practitioner or other higher-level nurse. Does related work as required.

** May also work in Immunization Clinic and be responsible for pediatric immunizations. **

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of an equivalency diploma, plus EITHER:

- (A) Graduation from a regionally accredited or New York State Registered college or university with an Associate's degree in Nursing, plus three (3) years paid full time or its part time equivalent experience as a Registered Nurse that involved hands-on care and patient assessment, one (1) year of which must have involved pediatric health care; OR,
- (B) Graduation from a regionally accredited or New York State Registered college or university with a Bachelor's degree in Nursing, plus one (1) year of experience as defined in (A) above that involved pediatric health care; OR,
- (C) Any equivalent combination of training and experience as defined by the limits of (A) and (B) above.

SPECIAL REQUIREMENTS:

1. Possession of a New York State Registered Professional Nurse's license and current registration to practice as a Registered Professional Nurse in New York State at the time of appointment or examination, whichever is first.
2. Candidates will be required to possess a valid license to operate a motor vehicle in New York State or otherwise demonstrate the capacity to meet the transportation needs of the job.
3. Candidates for employment with Monroe County Government will be required to pass a pre-employment drug test, along with a background investigation. Failure to meet the standards may result in disqualification.
4. Candidates for employment with the Monroe County Government will be required to pass a Pre-Employment Background Investigation. The candidate will be required to pay for the cost of fingerprinting, which is \$100.00. If the candidate is hired they will be reimbursed via payroll.

RESIDENCY REQUIREMENT:

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
