TITLE: THERAPEUTIC DIETICIAN (*Provisional Appointment)

SALARY: \$35,701.64 - \$45,796 per year

LOCATION: Monroe Community Hospital

JOB SUMMARY:

This is an important professional position involving responsibility for planning and overseeing dietary aspects of the food delivery system in a health care facility. Employees of this class work closely with medical personnel in assessing nutritional needs of residents, planning for the provision of food and drink appropriate for the individual's physical and medical needs, and providing nutrition education and counseling to adequately meet their regular or therapeutic needs. Work is performed under general direction of the facility administrator with leeway allowed for exercise of independent professional judgment. General supervision may be exercised over the work of the Dietetic Technicians and over the food service preparation staff. Does related work as required.

TYPICAL WORK ACTIVITIES:

- Assesses for the nutrient needs of residents as affected by medical regimens, drug therapy, and physical limitations;
- Develops dietary plan for providing nutritional care to residents;
- Confers with food service personnel, physicians, and nurses relative to the nutritional care plan;
- May counsel residents and their families regarding therapeutic diets and normal nutrition;
- Provides direction and guidance to the food service unit of the dietetic service to assure that foods served are satisfying to the residents and that preparation/service methods retain nutrients to inhibit the growth of micro-organisms;
- Works with facility personnel to insure that assistance is afforded to residents needing help with eating;

MINIMUM QUALIFICATIONS:

Graduation from a regionally accredited or New York State registered four (4) year college or university with a Bachelor's degree in Dietetics or Nutrition and completion of an approved Dietetic internship or its equivalent as determined by the New York State Department of Health.

SPECIAL REQUIREMENTS:

Must be registered with the American Dietetic Association at the time of examination.

Candidates for employment with Monroe County Government will be required to pass a pre-employment drug test, along with a background investigation. Failure to meet the standards may result in disqualification.

If you are appointed, you will be required to possess a valid license to operate a motor vehicle in New York State or otherwise demonstrate your capacity to meet the transportation needs of the position.

RESIDENCY REQUIREMENT:

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
