- (C) Seven (7) years paid full-time or its part-time equivalent experience as described in (A) above, one (1) year of which must have been in program supervision, program management, or program administration; OR,
- (D) An equivalent combination of education and experience as defined by the limits of (A), (B) and (C) above.

SPECIAL REQUIREMENTS:
