#### JOB SUMMARY:

This is a professional position at Monroe Community Hospital responsible for assisting in assessing needs of geriatric and long term care residents regarding recreational and leisure activities and overseeing the provision of services. The employee reports directly to, and works under the general supervision of, the Director of Resident Programs and Lifestyle Service. Does related work as required.

#### **MINIMUM QUALIFICATIONS:**

Graduation from high school or possession of an equivalency diploma, plus EITHER:

- (A) Graduation from a regionally accredited or New York State registered college or university with a Bachelor's degree in Recreation, Physical Education, Human Services\*\*, Gerontology, Music Therapy, Art Therapy or Dance Therapy, Psychology, or Sociology; OR,
- (B) Graduation from a regionally accredited or New York State registered college or university with an Associate's degree in one of the fields mentioned in (A), plus two (2) years of full-time or its part-time equivalent experience providing recreational activities, physical education, or art, dance or music therapy; OR,
- (C) Four years work experience as defined in (B) above; OR,
- (D) An equivalent combination of training and experience as defined by the limits above.
- \*\*For the purposes of these minimum qualifications, Human Services includes, but is not limited to, Social Work, Social Welfare, Counseling, Educational Psychology.

#### **SPECIAL REQUIREMENTS:**

Candidates for employment with Monroe County Government will be required to pass a pre-employment drug test, along with a background investigation. Failure to meet the standards may result in disqualification.

If you are appointed, you will be required to possess a valid license to operate a motor vehicle in New York State or otherwise demonstrate your capacity to meet the transportation needs of the position.

#### **RESIDENCY REQUIREMENT:**

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
