TITLE: SENIOR INDUSTRIAL WASTE TECHNICIAN (Provisional* Appointment)

- **SALARY:** \$38,969 \$49,422 annually
- LOCATION: Monroe County Department of Environmental Services

JOB SUMMARY:

This is a senior level technical position responsible for overseeing and participating in stormwater, industrial waste, and/or pollution prevention projects. This position differs from Industrial Waste Technician by virtue of scheduling field work, assigning staff, and providing lead supervision to crews on various project work. The employee must be able to move fifty (50) pounds. The employee reports directly to, and works under the general supervision of, an Industrial Waste Engineer or other higher level staff member. Lead supervision may be exercised over a technical staff. Does related work as required.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of an equivalency diploma plus EITHER:

- (A) Graduation from a regionally accredited or New York State registered college or university with a Bachelor's degree in Civil, Chemical, or Environmental Engineering or a closely related field, or one of the natural or physical Sciences, plus one (1) year paid full-time or its part-time equivalent experience in either storm water field investigations, or infrastructure design or maintenance, or water or wastewater chemical testing in a municipal industrial waste control section, or in the process operation (i.e. an active operator in the day-to-day operation) of an industrial waste control facility, water treatment facility, waste water facility or pollution control facility; OR,
- (B) Graduation from a regionally accredited or New York State registered college or university with an Associate's degree in Civil, Chemical, or Environmental Engineering or a closely related field, or one of the natural or physical Sciences, plus three (3) years paid full-time or its part-time equivalent experience as defined in (A) above; OR,
- (C) Five (5) years paid full-time or its part-time equivalent experience as defined in (A); OR,
- (D) An equivalent combination of education and experience as defined by the limits of (A), (B) and (C) above.

SPECIAL REQUIREMENTS:

Candidates for employment with Monroe County Government will be required to pass a pre-employment drug test, along with a background investigation. Failure to meet the standards may result in disqualification.

If you are appointed, you will be required to possess a valid license to operate a motor vehicle in New York State or otherwise demonstrate your capacity to meet the transportation needs of the position.

RESIDENCY REQUIREMENT:

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
