## MOTOR EQUIPMENT OPERATOR I

**DISTINGUISHING FEATURES OF THE CLASS:** This is a senior level position requiring the safe and efficient operation of medium and heavy equipment such as small and large trucks, dump trucks and trailers, bulldozers, payloaders, backhoes and graders. The work involves maintenance of diesel and gas powered motor equipment. The employee performs a variety of manual labor tasks. The Motor Equipment Operator I differs from Motor Equipment Operator by its responsibility for operating and maintaining heavy equipment on a regular basis. General supervision is received from a higher level employee. General supervision may be exercised over other equipment operators and laborers. The employee is required to be on twenty-four (24) hour call seven (7) days a week. Does related work as required.

**<u>TYPICAL WORK ACTIVITIES</u>**: (All need not be performed in a given position. Other related activities may be performed although not listed.)

Operates heavy equipment including dump trucks and trailers, bulldozers, payloaders, backhoes and graders;

Operates medium and heavy trucks to transport workmen and for the transportation of stone, gravel, asphalt, and other supplies;

Operates a snow plow and related snow removal equipment necessary for the cleaning and salting of roads;

Performs maintenance work on equipment including diesel and gasoline powered motor equipment;

Performs manual labor tasks such as laying pipe, setting manholes and loading equipment;

Performs minor maintenance work on equipment, including the adding of oil and other fluids;

Oversees the work of other equipment operators and laborers on an occasional basis;

Assists with other tasks related to routine maintenance;

Provides training to lower level staff in the performance of duties specific to the location.

## FULL PERFORMANCE, KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Good knowledge of the safe and efficient operation of medium and heavy motor equipment and power tools; good knowledge of the proper use and application of standard and special motor equipment and power tools; good knowledge of the care and maintenance of diesel and gas powered medium and heavy motor equipment; ability to follow verbal and written instructions; ability to perform manual labor; ability to establish good working relationships with others; mechanical aptitude; manual dexterity; dependability; resourcefulness; willingness to work outdoors under adverse weather conditions; ability to oversee the work of others; physical condition commensurate with the demands of the position.

**<u>MINIMUM QUALIFICATIONS</u>**: Three (3) years paid full-time or its part-time equivalent experience in the operation of medium and heavy trucks and motor equipment.

**<u>SPECIAL REQUIREMENTS</u>**: Possession of a valid New York State Class \*A\* Commercial Driver's License (CDL).
